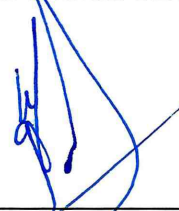
Asimismo, se informó el monto total a que ascienden las Propuestas Económicas que fueron analizadas en la presente reunión.

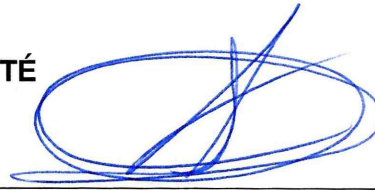

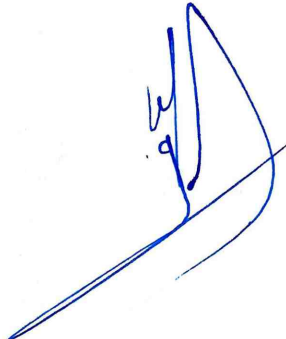
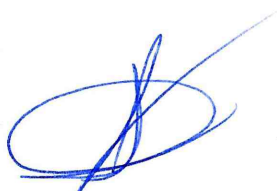
